Rescuing Europe's industry: time to break free from the Green deal trap

The European Commission's responses to Europe's competitiveness crisis follow one another, as do the disappointments. We can legitimately wonder whether Ursula von der Leyen has taken the measure of the crisis we are going through after five years of over-regulation linked to the Green Deal.

During this plenary session, we will be discussing energy-intensive industries, the heavy industries that form the backbone of the continent's economy. The proposals that the Commission is making in its 'clean industrial deal' for these sectors are largely insufficient and are, once again, in line with the logic of the Green Deal.

The Patriots' Group is proposing strong and coherent measures. Firstly, with regard to electricity, we are calling for nuclear energy to finally regain a real place in European policy, and to benefit from the same advantages as other sources of electricity.

We must get away from the deadly European mechanism of fixing energy prices, to return to competitive prices compared to China or the United States. We are also calling for a review of public procurement rules in order to establish a true European preference as well as trade defence tools.

It is becoming more urgent every day to suspend the Green Deal and to review detail what in this policy handicapping our companies. obstinacy of the European Commission and of the majority political groups in pursuing this course of action is condemning our companies, strangling our farmers and killing the purchasing power of citizens. This week in Strasbourg, we will defend a policy that will finally put Europe on the path to growth.

The Commission's Green Chaos: Cleaning Up Its Own Mess, One Delay at a Time

Here we go again. Another urgent procedure, another "simplification package", and another desperate attempt by the European Commission to cover up its own policy failures—with a smile.

This week, MEPs are being asked to fasttrack a vote on "omnibus" directive, which postpones key obligations under the Corporate Sustainability Reporting Directive (CSRD) and the Corporate Sustainability Due Diligence Directive (CSDDD). These were once hailed as the Commission's flagship Deal Green Today? the instruments. Even Commission admits they're unrealistic, economically overburdening, and damaging. This proposal doesn't fix anything. It merely delays the disaster. The reporting obligations for thousands of companies are being pushed by two years—until 2027 and 2028—because otherwise, companies would be forced to prepare for rules that might never come into force in their current form. That's not planning. That's chaos control

And while we're on chaos: let's not forget that the vote on the automotive industry resolution was just pulled from plenary. this Why? Because Commission might bring new proposal. Might. In the meantime, Europe's car industry—once a symbol of innovation and strength—is left in limbo. No certainty, no strategy, just Brussels fog.

Let's be honest: this is not simplification. It's bureaucratic procrastination. The Commission is buying time, not solving problems. It's rewriting its mistakes instead of admitting them—and asking us to rubber-stamp it.

We stand for real deregulation, for legal certainty, and for an EU that doesn't leave its entrepreneurs, workers and industries drowning in red tape while waiting for yet another "new proposal". Enough is enough. Europe deserves clarity, not delay. Leadership, not excuses.

Turkey will never share our European values

Rule of law, democracy, freedom of speech, human rights—these are all concepts that do not exist in NATO member state and EU applicant Turkey. Corruption, violence, rigged elections, support for Islamist causes, and the imprisonment of journalists and political opponents, however, are all too familiar.

On March 19, Recep Tayyip Erdoğan, Turkey's supreme leader since 2003, had Istanbul Mayor Ekrem Imamoğlu arrested. Eager to hold on to power after the 2028 presidential elections, Erdoğan imprisoned his main political rival, the opposition's leading presidential candidate. He also revoked Imamoğlu's university degree, a requirement for presidential candidates.

Moreover, in true Erdoğan fashion, Imamoğlu was vilified and incarcerated on charges of corruption, terrorism, and treason. Thousands of Turks have taken to the streets in mass protests, despite the aggressive response of Erdoğan's riot police and restrictions on social media. They demand Imamoğlu's release and call for Erdoğan to be jailed for corruption, terrorism, and treason instead.

Recep Tayyip Erdoğan has shattered the last remnants of Turkey's democratic credibility. In 2019, the EU suspended Turkey's accession process. It is time to put an end to it entirely. Expressing concern and "urging transparency," as High Representative Kaja Kallas does, is not enough. Turkey is not a European country, it does not share our European values, and it never will. Brussels must finally face this reality.

New EU strategy threatens Member States' sovereignty

The European Commission's recently unveiled 'EU Preparedness Union significant Strategy' has sparked criticism, with many viewing it as a veiled attempt to centralize under the pretense of crisis management. Rather than taking proactive steps to avert crises, the EU appears to be leveraging them as an excuse to expand its authority. The Union should be focused on preventing turmoil: instead, it allows conflicts to at our doorstep while suggesting that we prepare for such eventualities—a stance that many consider profoundly cynical.

Moreover, the EU is encroaching upon powers that it does not rightfully hold. This not only threatens the security independence of member states but intentionally exceeds acceptable limits of what a union of sovereign nations can enact. Austria's constitutionally protected neutrality must not be compromised as a bargaining chip for a centralizing European Union.

As members of the PATRIOTS, the Austrian Freedom Party firmly believe that the EU must return to its fundamental mission of fostering peace, security, and cooperation.

Instead of fabricating new crisis scenarios and gravitating toward militarized structures, we advocate for a recommitment to the core principles of European ideal—namely, escalation, diplomacy, and unwavering respect for the sovereignty of Member States. The McAllister Report: Centralisation at the Expense of Sovereignty

The McAllister report on the Common Foreign and Security Policy (CFSP), up for vote in the next plenary, pushes for further integration and centralisation of EU foreign policy. While cooperation is important, this vision sidelines national sovereignty and imposes a one-size-fits-all doctrine shaped by Brussels bureaucrats, far removed from the concrete realities of each Member State.

This approach is especially problematic for smaller, peripheral and maritime countries—from Portugal and Greece to Ireland, Finland, and the Baltic States—whose foreign policy and security needs are deeply shaped by unique geographies, historical alliances, and strategic positions.

Many of these nations have centuriesold diplomatic traditions and specific regional threats that cannot be addressed through a centralised, continental perspective. By enhancing the role of unelected EU bodies in defining common positions, the report risks homogenising national diplomacy and diluting the strategic priorities of individual states. Countries on the periphery may find their maritime, border, or regional concerns deprioritised in favour of dominant narratives set by larger Member States with very different agendas.

Instead of empowering Brussels, the EU should respect diversity and promote voluntary cooperation among sovereign nations. A strong and united Europe is only possible when national voices are not only heard—but trusted.

Foreign policy cannot be effective when dictated from the centre. It must be anchored in sovereignty, regional knowledge, and democratic legitimacy.

A plan that misses the real issue

The 'action plan for the automotive industry' presented by the European Commission is just a smokescreen. announcements Rehind the batteries, connected vehicles and social benefits, it merely reinforces ideological orientation: that of banning the sale of combustion vehicles from 2035. This dogmatic choice continues to impose all-electric without respecting fundamental principle the technological neutrality.

The Commission is enthusiastic about autonomous and connected vehicles, even though the network of charging stations is far from ready.

The 1.8 billion euros for raw materials, or the billion promised for automotive AI, mask the essential: low-income households are excluded from this transition, as shown by the fiasco of social leasing in France, which has been renewed in 2025 with reduced subsidies.

The forced greening of company fleets, unchanged CO₂ standards and the strengthened environmental label from 2026 accentuate the pressure on an already weakened sector.

As for the social aspect, it anticipates layoffs without challenging the imposed course.

This plan, far from being a strategic response, is a technocratic cover-up. We need to open the debate on 2035: it is this deadline that needs to be reviewed, to preserve our industry, our jobs and the freedom of movement of Europeans.

Steel Promises, Rusting Reality: The Flawed Vision of Europe's Metals Plan

The so-called European Action Plan for Steel and Metals is yet another demonstration of how disconnected the European Union is from the real needs of our territories. Instead of offering concrete solutions, Brussels provides weak and ineffective measures in the face of serious challenges.

Europe's steel and metal industries are being crushed by skyrocketing energy costs and ever-increasing international competition. Yet the Plan fails to offer any meaningful support. Talking about decarbonisation is not enough: we need to ensure that our companies can compete on equal terms, not be buried under EU-imposed rules devised by those who have never set foot in a factory.

Even worse, the Plan places further financial burdens on companies to adapt to the much-desired green transition, with no real concern for their economic sustainability — already under severe pressure due to inflation and years of failed European policies.

The result? A real risk of further delocalisation and the gradual deindustrialisation of Europe.

As patriots, we call for a different approach: enough with ideological dogmas. What we need are targeted investments, affordable energy, and real protection from unfair competition. That is why, together with the Lega delegation to the European Parliament, I submitted a written question to the European Commission, asking for clear answers on how it intends to guarantee the protection of our industrial base. As coordinator of the ITRE Committee, I will continue to fight to ensure this Plan does not become yet another empty document. This dystopian display reminds us of the Capitol elites in The Hunger Games — out of touch, theatrical, and terrifyingly frivolous.

War is not glamorous. War means death. Every week, hundreds of young Ukrainians die on the battlefield. While Brussels bureaucrats play Napoleon in their carpeted offices, it is European lives they are risking.

We choose peace. VOX supports the negotiations led by the United States to bring an end to the suffering of the Ukrainian people. Europe must not obstruct these efforts.

We reject the warmongering rhetoric pushed by Brussels bureaucrats and echoed in Spain by the Popular Party and the Socialist Party. Powering Europe's Backbone: Saving Energy-Intensive Industries

Europe's energy-intensive industries—steel, chemicals, cement—are the backbone of our economy, yet Brussels' Clean Industrial Deal (CID) threatens to snap it. EU electricity prices, 2-4 times higher than global competitors', are a death knell for manufacturers already battered by China's 550-million-tonne steel overcapacity. The CID's vague promises of "green premiums" and voluntary labels are regulatory fluff, not salvation for struggling workers.

High energy costs are Brussels' gift to foreign rivals. While the Commission pumps €1.8 billion into battery tech reliant on Chinese raw materials, EUROFER warns the Carbon Border Adjustment Mechanism (CBAM) fails to shield EU producers from cheap imports or support exporters.

Decarbonization dogma doubles the pain: firms face soaring bills and compliance burdens, forcing layoffs, while competitors thrive on pragmatic policies.

We should reject this suicide pact. Suspend the CID's unworkable decouple mandates and electricity prices from volatile gas markets households and factories deserve relief, not punishment. Scrap the combustion engine ban bleeding related sectors dry. Redirect misspent funds, like the €15 million LIFE programme handouts to NGOs, to subsidize energy protect jobs, and stabilize costs, communities.

Sovereignty demands a competitive edge, not green shackles. China's state-backed industries don't play by Brussels' rules—neither should we. A real plan prioritizes affordable energy, robust trade defences, and regulatory cuts over ideological experiments. Without it, Europe's industrial heartland will wither, its workers and families left to pay for the Commission's climate obsession. Leadership means strength, not surrender—act now.

The EU Talent Pool: Europe's Self-Inflicted Decline

The European Union is no longer a champion of progress, it has become an architect of its own demise. proposed EU Talent Pool, disguised as a solution to labour shortages, is in reality a blueprint for demographic economic suicide. While Brussels sells it as an efficient migration tool, the fine print reveals a radical agenda: 7 million new migrants by 2030, on top of existing illegal asylum and inflows. represents not just a policy shift, but a fundamental redefinition of Europe's future.

The scheme claims to target skilled workers, but in practice, it will flood Europe with low-cost labour, turning into temporary permanent gaps dependency. Worse, it ignores the fiscal reality: studies show low- and midskilled migrants are net drains on welfare systems over their lifetimes. Short-term corporate gains will be dwarfed by long-term societal costs: overburdened public services, wage suppression, cultural and fragmentation.

Meanwhile, the EU's obsession with mass migration distracts from real solutions: automation, workforce activation, and pro-natal policies. Other nations protect their interests, the U.S. tightens borders while boosting productivity, even the UK's Labour Party now resists unchecked flows. Yet Europe's elites march blindly toward a future of decline, sacrificing sufficiency for the illusion of cheap labour.

The choice is clear: either Europe reclaims its economic sovereignty by investing in its own people and technology, or it condemns itself to irreversible dependency. The Talent Pool isn't a lifeline, it's an anchor dragging Europe down.

The process of EU federalization is ongoing

The EU is using all possible crises to takeover more competences of the Member States. This was during the financial or the pandemic past crises. Over the last years the Commission has been interfering in the judiciary, energy policy and climate finance. This time, the EU is using the war in Ukraine and the relations crisis in with the US administration as a pretext to centralise power in the Union. The process of EU federalization is ongoing.

European Commission's White Paper on European Defence aims to deepen the integration of the defence industry. The plan envisages raising more than EUR 800 billion from increased defence spending borrowing on behalf of Member States. Under the slogan of "support for Ukraine", EU politicians have pushed for a common debt that countries will pay back for several decades and, unlike the covid fund, the current fund is consists only of loans to Member States.

The European Commission also want a mandate to purchase military equipment on behalf of the Member States. It also consider the abolition of unanimity in the Council and the European Council in the field of security and defence policy and the call for the repeal of Article 346 of the Treaty on the Functioning of the EU, i.e. the protection of the interests of Member States, which defend countries to their use sovereignty.

If the new programme enters into force, it will be another bureaucratic tool of the European Commission.
